ARTICLES OF REVIVAL (Title 3, Subtitle 508-509-510 of "Corporations and Associations Article" of the Annotated Code of Maryland)

THE TIMBERS CIVIC ASSOCIATION, INC., a Maryland Corporation, having its principal office in Anne Arundel County, Maryland, hereinafter called the "Corporation", hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The charter of the Corporation was forfeited on December 20, 1976, for the non-payment of taxes and for failure to file an annual report with the State Department of Assessments and Taxation of Maryland, and these Articles of Revival are for the purpose of reviving and reinstating the charter of the Corporation.

SECOND: The name of the Corporation at the time of the forefeiture of it's charter was THE TIMBERS CIVIC ASSOCIATION, INC.

THIRD: The name by which the Corporation will hereafter be known is THE TIMBERS CIVIC ASSOCIATION, INC.

<u>FOURTH</u>: (a) The post office address of the principal office of the Corporation in the State of Maryland is 1222 Timber Turn, Arnold, Maryland 21012, Anne Arundel County, and said principal office is located in the same County in which the principal office of the Corporation was located at the time of the forfeiture of it's charter. FIFTH: At or prior to the filing of these Articles of Revival, the Corporation has:

(b) Filed all annual reports which should have been filed by the Corporation if its charter had not been forfeited; (c) Paid all State and local taxes (other than taxes on real estate) and all interest and penalties due by the Corporation, irrespective of any pe. od of limitation otherwise prescribed by law affecting the collection of any part of such taxes; and (d) Paid an amount equal to all State and local taxes (other than taxes on real estate) and all interest and penalties which, irrespective of any period of limitation otherwise prescribed by law affecting the collection of any part of such taxes, would have been payable by the Corporation if its charter had not been forfeited.

SIXTH: The last acting President, Vice-President, Secretary and Treasurer of the Corporation are unable to sign and acknowledge these Articles of Revival; and these Articles of Revival are, therefore signed and acknowledged by the undersigned elected officers of the Corporation.
